The type locality for Buena Vista Sandstone from Scioto County, Ohio—the topic of an article on pages 35-49 by David B. Saja and Joseph T. Hannibal—was first described by Orton when he worked for the Ohio Geological Survey in 1874. Orton Hall is geologically correct. From the oldest stones in the foundation to the top of the tower, the ages of the building stones begin with the oldest and end with the youngest.
